Bylaw No. 10-2016

A BYLAW TO PROVIDE FOR ENTERING INTO AN AGREEMENT WITH THE VILLAGE OF LOREBURN RESPECTING THE PROVISION OF FIRE PROTECTION SERVICES

The council of the Rural Municipality of Loreburn No. 254, in the Province of Saskatchewan, enacts as follows:

- 1. The Rural Municipality of Loreburn No. 254 is hereby authorized to enter into the agreement, attached hereto and forming part of this bylaw, and identified as Schedule 1, with the Village of Loreburn for the purpose of providing and/or receiving fire protection services.
- 2. The Reeve and Administrator of the Rural Municipality of Loreburn No. 254 are hereby authorized to sign and execute the attached agreement identified as Schedule 1.
- 3. Bylaw No. 03-2015 shall be repealed.

INTER-MUNICIPAL FIRE PROTECTION AGREEMENT

Memorandum of Agreement made this 11th day of July, 2016, A.D.

Between:

The Village of Loreburn

and

The Rural Municipality of Loreburn #254

This Agreement Witnesseth as Follows:

- l. That the Village of Loreburn agrees to provide fire protection services throughout the "designated area" and that all residents residing within the designated area are protected under this agreement. In this agreement the designated area includes: see attached map.
- 2. The parties to this agreement further agree to the following terms:
 - The Village of Loreburn Fire Chief will be responsible for training fire fighters, storage and maintenance of firefighting equipment and the dispatching of equipment and manpower.
 - In the event of simultaneous fires priority will be given to Villages in our own district, depending of severity of fires.
 - The Village of Loreburn is responsible for insurance on the firefighting equipment.

3. Fire Fighting Fees:

- There will be no charge for residents of the Village of Loreburn. Fire Fees for all other areas covered in this Bylaw will be assessed a Fire Fee of \$750.00 for fire calls with the Village of Loreburn Fire Truck and water truck. If the Water tank from the Village of Strongfield is used there will be an additional charge of \$150.00.
- The Rural Municipality of Loreburn #254 will give a grant of \$800.00 (eight hundred dollars) a year to the Loreburn Fire Department.

The Rural Municipality of Loreburn #254 will enforce the collection of any fire call charges that have been incurred by the Village within the Rural Municipality of Loreburn #254 and are still outstanding at the end of the year, by adding them on December 31 of that year on the tax roll. Upon collection, the charges plus interest Accrued will be forwarded to the Village in payment for the service.

- 4. It is understood that this agreement will be continuous and may be terminated by either party to the agreement giving thirty days' notice in writing.
- 5. This Agreement replaces all previous agreements.


