That we renew our membership with South Saskatchewan River Watershed Stewards for 2016.

That we pay an honorarium of \$40 to First Responders that respond to 911 calls within the RM of Loreburn # 254 boundaries.

That we pay for 1/2 of Verna Urlacher's expenses for attending the First Responders Conference in Moose Jaw.

That we agree to maintain the roadways within the Gardiner Dam Maintenance area for the period of April 1, 2016 through to March 31, 2017 and charge our non-ratepayers custom rates for 2016.

That we change the criteria for the LCS Scholarship to the following: Any student that is graduating from the Loreburn Central School is eligible to apply. The applicant must be continuing their education in a field of their interest after graduation. Other criteria that will be looked at is community involvement and school leadership. The applicant must contact the sponsor after completing 3 months if apprenticing, first term of post-secondary/college or course completion.

That we pay for the RM Christmas Party expenses.

That we will provide the Elbow and District Wildlife Federation a donation to be used towards the Lake Diefenbaker Walleye Classic.

That we send a letter to SaskPower with concerns from ratepayers on the conditions that SaskPower has left ratepayers fields in when accessing them and that ratepayers were not notified that the work was going to be done.

That we approve the subdivision for SW 26-27-5 W3 as it is compliant with our Zoning Bylaw 02/2013 Sec 7.1.3.

That we renew our membership with Central Area Transportation Planning Committee.

That we accept Hole Shot Services quote for 2016 gravel spreading.

That we hire Baschuk Construction Ltd. from Saskatoon for gravel crushing for the RM of Loreburn #254.
